- 1. International Dark Sky Association Annual Meeting Sponsorship
 - This sponsorship is a no-cost show of support for the mission of the Dark Sky Association, acknowledging the ecological impacts of light pollution.
 - As wildlife professionals, we see impacts of light pollution on wildlife so this seems like a
 reasonable group to support, and it costs us nothing other than allowing them to use our name
 as a sponsor.
 - Voted in favor (unanimous vote) in favor of being a sponsor of the Annual Meeting of the Dark Sky Association to be held in Scottsdale in November 2015
- 2. AZTWS Letterhead Ryan
 - Letterhead finalized and has been sent out to membership in Word and PDF, for everyone's use as needed.

 - Can new boards be purchased for \$4500? We don't know but will wait to hear back from Sharon Lashway.
